- 1) Tickets are \$100 each or 3 tickets for \$250.
- 2) Winner must accept delivery of the vehicle within 90 days from when the Ram is released from DaimlerChrysler. The vehicle is U.S. DOT specification and the winner must take delivery from a U.S. SRT dealership of his or her choice. Winner will be contacted by telephone and receive certified mail notification.
- 3) All applicable taxes, license and fees are the responsibility of the winner based on the retail value of the prize. Federal law requires the deposit of 25% of such value to be applied toward the winner's tax liability before the prize can be released.
- 4) Odds of winning the vehicle will be based on the total number of tickets sold, but no greater than 2,750 to 1.

- 5) Tickets will be issued only to the name(s) listed on the ticket form itself. The prize will be awarded on the same basis. Winning ticket cannot be assigned, transferred or sold.
